

## **Our Company Privacy Policy**

Chris Dziadul is represented by May Twin Media Limited, a UK-registered company founded and solely owned by Chris Dziadul. This privacy policy will explain how May Twin Media uses the personal data it collects from you when you use the Chris Dziadul website.

### **What data do we collect?**

May Twin Media collects the following data:

- Personal identification information (Name, email address, phone number, etc)
- Company contact details

### **How do we collect your data?**

You directly provide May Twin Media with most of the data we collect. It collects data and processes data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Use or view our website via your browser's cookies.

### **How will we store and use your data?**

May Twin Media is hosted on the Wix.com platform. Wix.com provides us with the online platform that allows us to sell our products and services to you. Your data may be stored through Wix.com's data storage, databases and the general Wix.com applications. They store your data on secure servers behind a firewall.

May Twin Media collects your data so that we can:

- Process your order, manage your account.
- Email you with special offers on other products and services we think you might like.

When May Twin Media processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

All direct payment gateways offered by Wix.com and used by May Twin Media adhere to the standards set by PCI-DSS as managed by the PCI Security Standards Council, which is a joint effort of brands like Visa, MasterCard, American Express and Discover. PCI-DSS requirements help ensure the secure handling of credit card information by our store and its service providers.

### **Marketing**

May Twin Media would like to send you information about products and services of ours that we think you might like, as well as those of our partner companies.

If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop May Twin Media from contacting you for marketing purposes.

If you no longer wish to be contacted for marketing purposes, please contact us by email.

### **What are your data protection rights?**

May Twin Media would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

**The right to access** - You have the right to request May Twin Media for copies of your personal data. We may charge you a small fee for this service.

**The right to rectification** - You have the right to request that May Twin Media corrects any information you believe is inaccurate. You also have the right to request May Twin Media to complete information you believe is incomplete.

**The right to erasure** - You have the right to request that May Twin Media erase your personal data , under certain conditions.

**The right to object to processing** - You have the right to object to May Twin Media's processing of your personal data, under certain conditions.

**The right to data portability** - You have the right to request that May Twin Media transfer the data that we have collected to another organisation, or directly to you, under certain circumstances.

If you make a request, we have one month to respond to you. If you would like to exercise any of these rights, please contact us by email.

### **What are cookies?**

Cookies are text files placed on your computer to collect standard internet log information and visitor behaviour information. When you visit our website, we collect information from you automatically through cookies or similar technology.

## **What type of cookies do we use?**

There are a number of different types of cookies. However, our website uses:

- **Functionality** – May Twin Media uses these cookies so that we recognise you on our website and remember your previously selected preferences. These could include what language you prefer and location you are in. A mix of first-party and third-party cookies are used.
- **Advertising** – May Twin Media uses these cookies to collect information about your visit to our website, the content you viewed, the links you followed and information about your browser, device and IP device. May Twin Media sometimes shares some limited aspects of this data with third parties for advertising purposes. We may also share online data collected through cookies with our advertising partners. This means that when you visit another website, you may be shown advertising based on your browsing patterns on our website.

## **How to manage cookies**

You can set your browser not to accept cookies, and the above website tells you how to remove your cookies from your browser. However, in a few cases some of our website features may not function as a result.
